## **Dear School Families:**

Grace will continue with a two-tiered tuition schedule for this year. The School Committee established the new tuition rates with a slight increase to accommodate a small raise in salaries for teachers and also to cover the increases in school supplies and equipment needed for the coming year.

The charts below show a breakdown of the payment schedules for the two-tiered tuition for elementary and middle school students. Tuition paid in monthly or quarterly installments must be direct debits from your bank or credit card via contract agreement with FACTS Management. ONLY payments in full by August 18 or in two installments (August and January) may be paid directly to the school.

AN AUGUST PAYMENT IS MANDATORY IF STUDENT(S) ENTRY/ACCEPTANCE DATE IS BY AUGUST 31. ALL PAYMENTS ARE SUBJECT TO LATE FEES IF NOT PAID BY SCHEDULED DUE DATES AND SERVICE FEES IF PAYMENT IS REJECTED BY THE BANK.

Enrollment/Re-enrollment fee per student has been set at \$535 for the 2017-18 academic year. Parents may re-enroll students beginning **February 1**<sup>st</sup> by completing the re-enrollment forms and paying the Enrollment Fee in full online via Renweb with a credit card or directly to the school as a check or cash. Enrollment for new students will begin as of April 1, 2017, so we encourage our current families to enroll early to reserve their students' class space.

Tuition debits/payments will be waived in March and moved to a May date (<u>no later than the 15<sup>th</sup></u>) to allow a "tuition free" month for parents with re-enrolling students, with the exception of 8<sup>th</sup> grade students.

Families with returning students currently holding a FACTS Agreement will have that contract renewed with the new tuition rates per student. Families with multiple students enrolled will have a combination of the listed tuition amounts depending on grades of each student. Notice of activation will be sent by April 30 if student enrollment has been paid for the next school year. Families with an established FACTS Agreement may also make full tuition payment online ON OR BEFORE AUGUST 18, 2017.
